Letter

In 1995, I was living on a remote beach in Malawi running a hostel I had bought from the local chief. At the ripe age of 22 I was the proud owner of a few run down huts on a beach in Africa that you could only get to once a month by boat.

Living there, I spent a lot of time in the local village, getting to know people, meeting with community leaders and hearing about the challenges the community faced.

Inspired to help them, I began to think about how volunteers could really help address the problems they encountered on a day-to-day basis.

I called my old friend Ben who was carrying out marine research in Honduras. During university we had both had amazing experiences volunteering, but felt the experience and the sustainability of the impact could have been greatly improved.

Together, we set out to build an organization that worked hand in hand with local communities to build sustainable environmental and humanitarian volunteer projects. We believed that because of the long-term vision and community involvement in our projects, volunteers would ultimately have a deeper, more responsible and more rewarding personal experience.

It is this same commitment to running only long-term projects that demonstrates our passion to help people and improve the communities we work with.

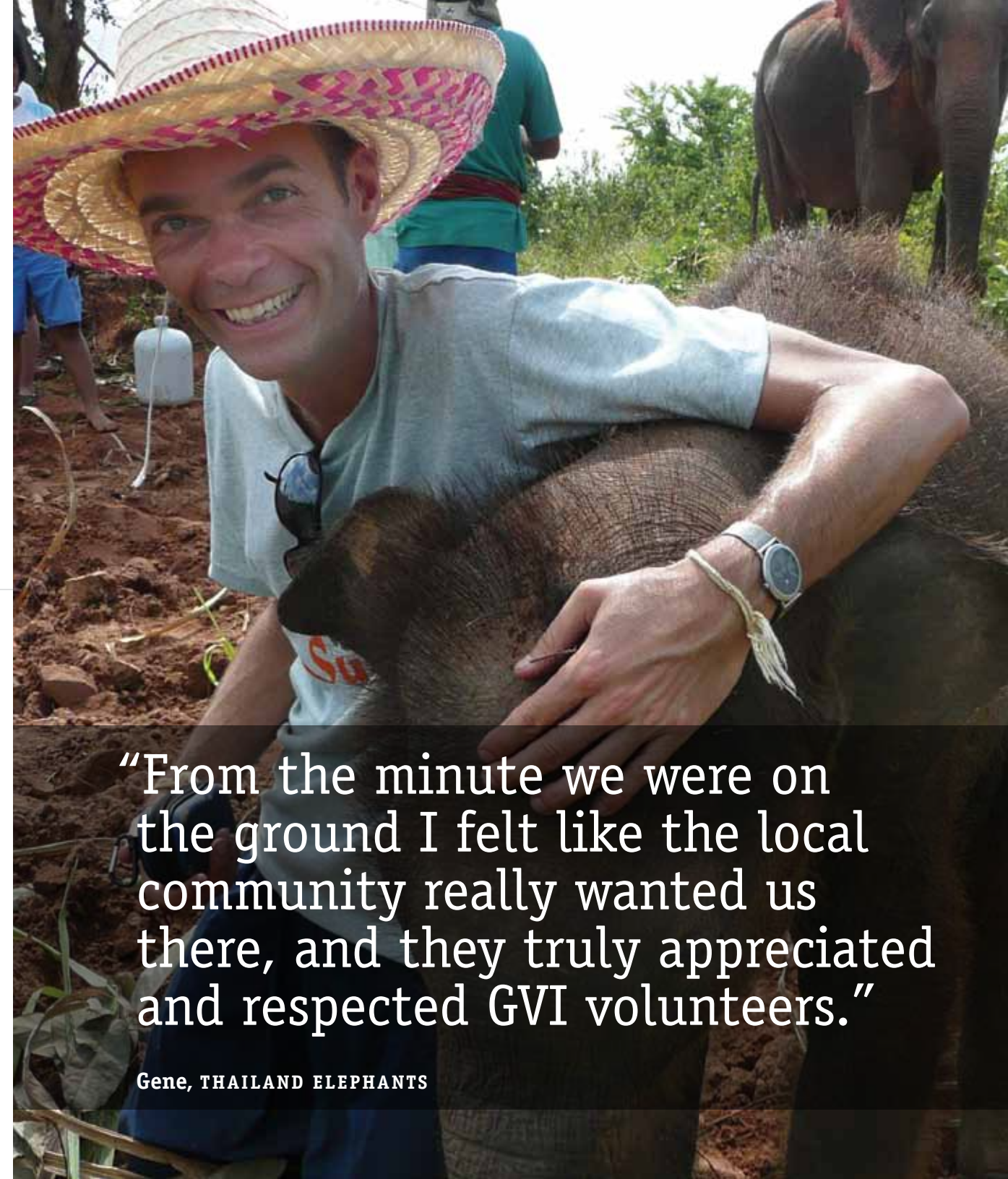
Internships

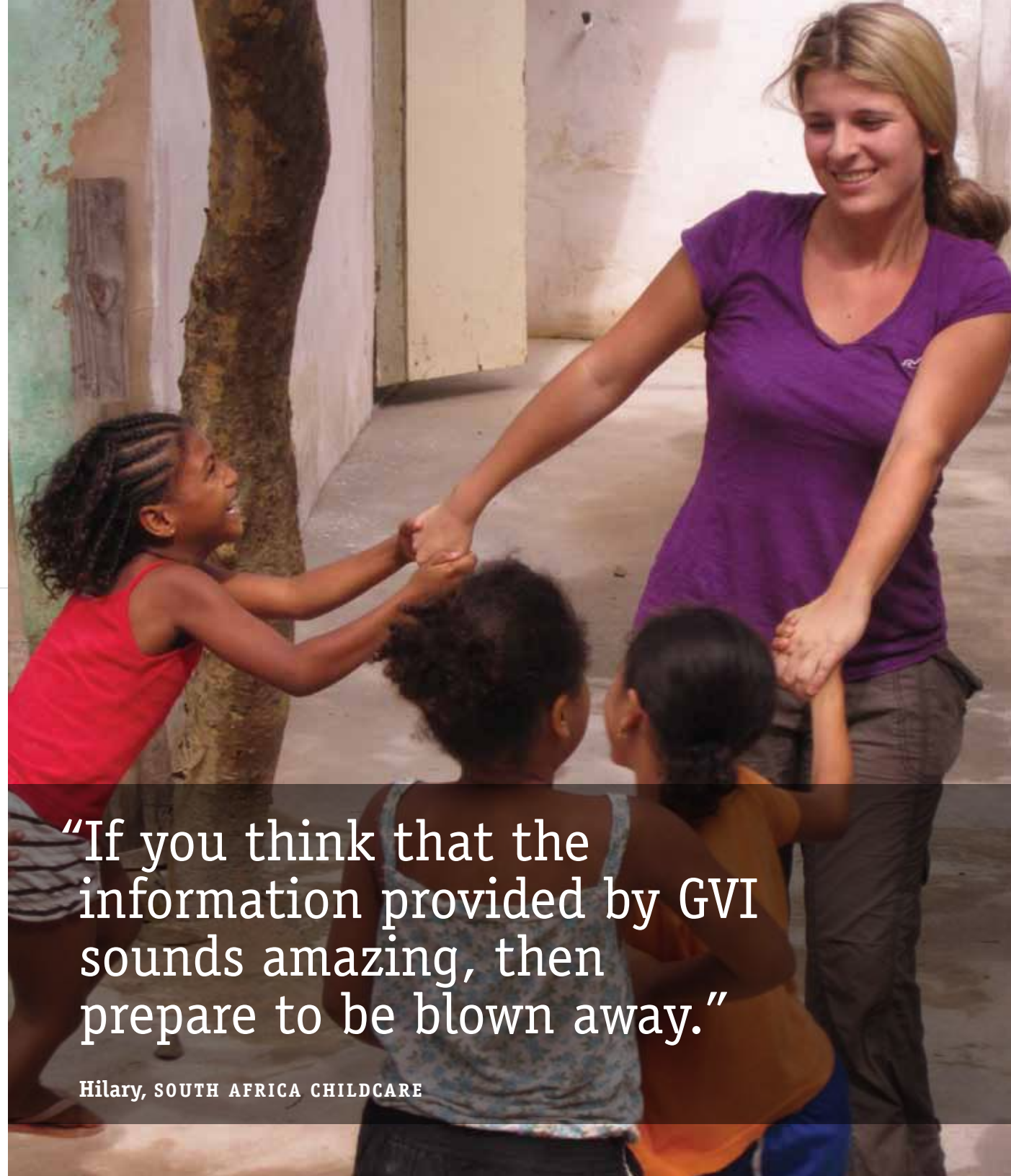

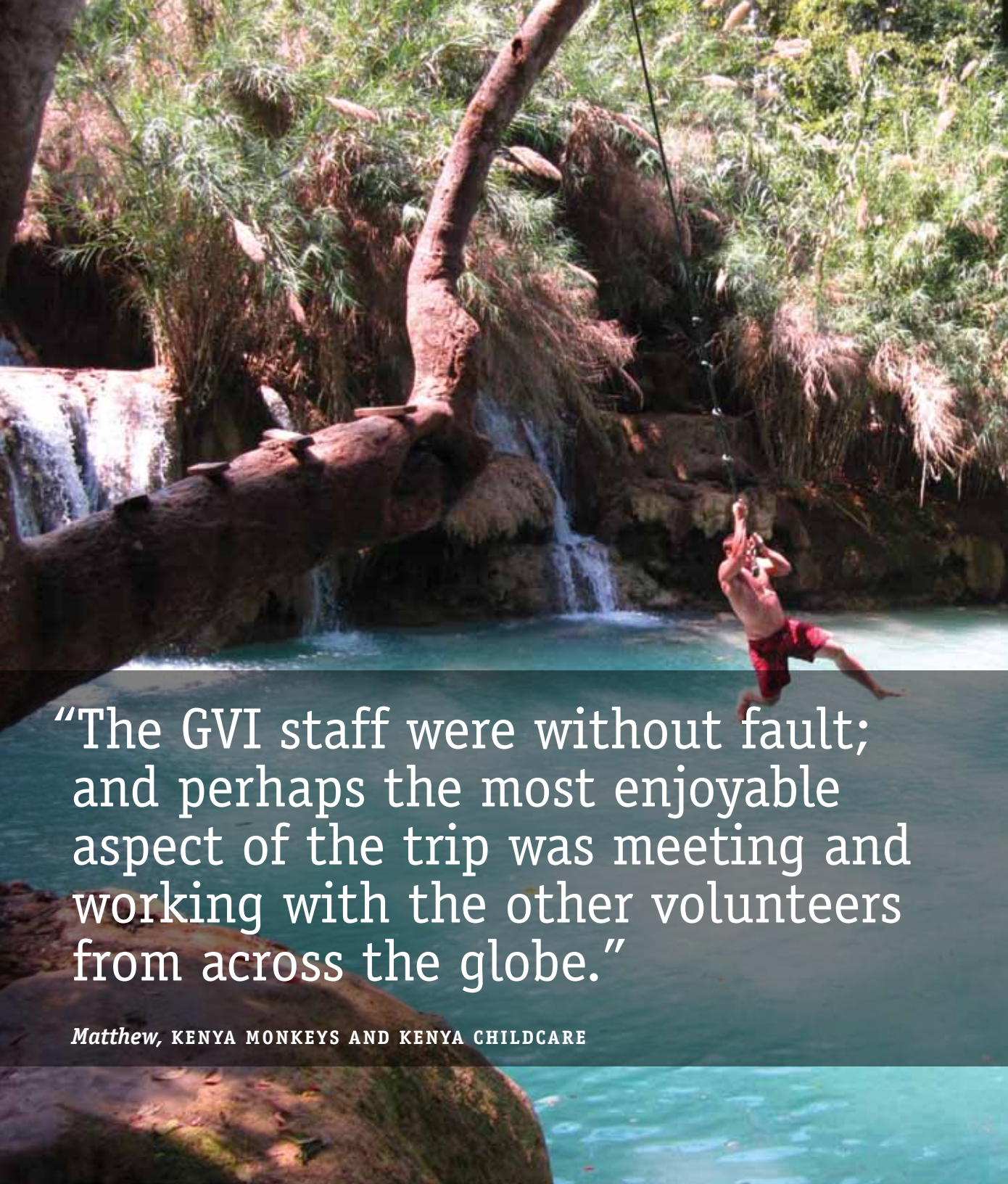
We take health and safety more seriously... Feel free to stack any other organization's health and safety protocols and procedures against ours. We're confident ours are more comprehensive.

GVI Hubs

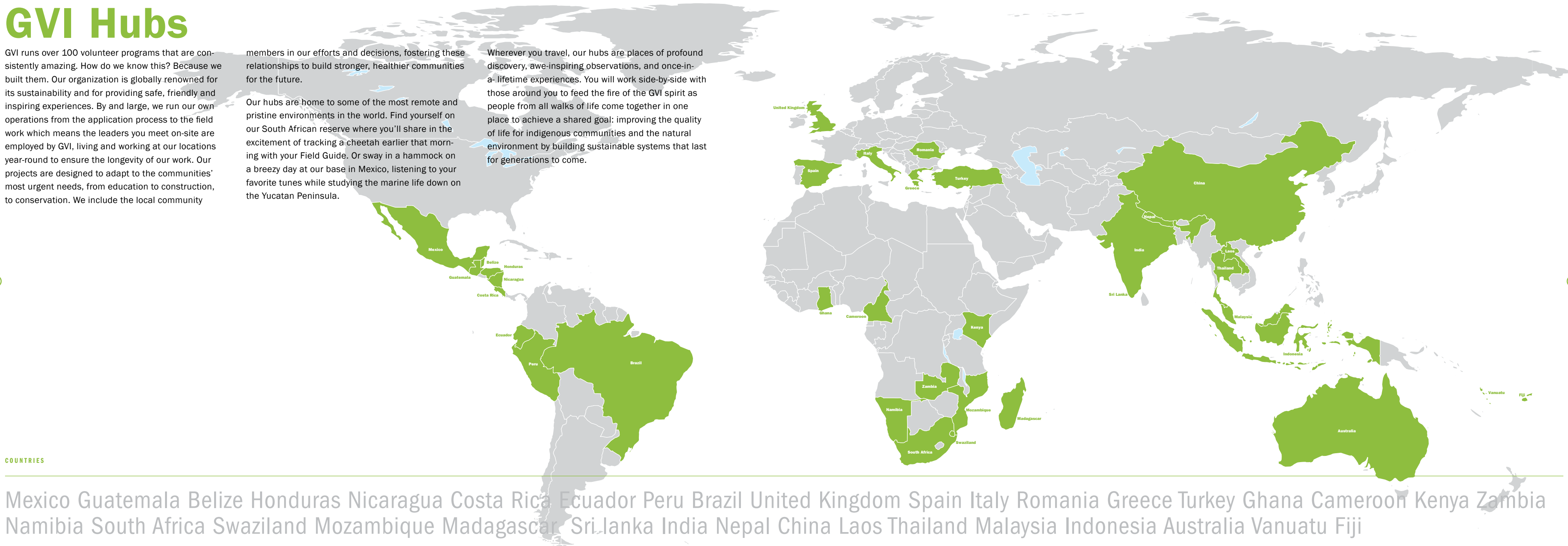

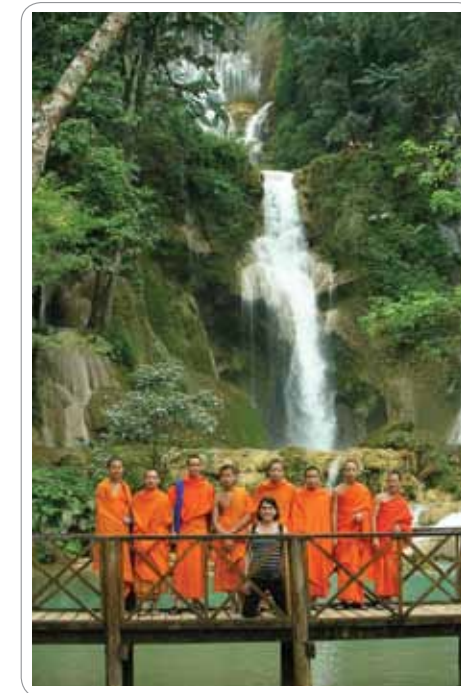

Where the Money Goes

Since we opened our doors in 1997 GVI has spent over 70% of all funds directly on our projects. It is our mission to support field operations in the long term. Rather than abandon programs that recruit fewer volunteers we strategically invest from our fully staffed sites to help maintain our presence across the globe.

The remaining 30% that is not directly invested in our programs covers the cost of volunteer recruitment, the operations of our head offices, and the support of projects indirectly through the GVI Charitable Trust. Our offices are of vital importance to ensuring the safety and well-being of all our volunteers and our charity is an essential tool of providing financial support to our ongoing efforts.


- 100 fully funded, long-term volunteer projects globally
